### UW HLC Peer Review Visit November 18-19, 2019 Laramie and Casper

Each week until the HLC peer review team visit, the UW HLC Ops Group is sending news shorts to help you prepare for their visit!



The Higher Learning Commission (HLC) accredits higher education institutions in the 19-state north-central region of the U.S. They comprehensively review UW every 10 years to affirm that we meet the [criteria](#) for continued accreditation.



Continued accreditation by HLC assures that UW can offer federal financial aid for its programs, and makes it possible for UW to receive grants and scholarship funding from government agencies, foundations and other funders who

typically only fund regionally accredited universities. Our students are also able to seek admission to graduate and professional programs that require applicants to have a bachelor's degree from a regionally accredited college or university. In addition, a professional license in fields such as nursing or teaching usually requires a degree from a regionally accredited school.
